Henry County Health Department

History:

In June of 1966, the Henry County Health Department was formed by resolution of the Henry County Board. The primary intent of the Health Department was to make home health nursing visits to Medicare patients in Henry and Stark Counties.

In March of 1976, the Henry County Tuberculosis Sanitarium Board was abolished and all assets and liabilities of the Sanitarium Board were transferred to the Health Department.

In 1978, the Health Department received full certification as a Local Health Department with all 10 required programs receiving approval from the Illinois Department of Public Health.

On November 3, 1987, Henry County voters passed a Public Health Referendum to support Health Department programs and services. The referendum gathered 61% of the votes and set the maximum appropriation of \$.10 per \$100 of assessed property valuation.

On December 6, 1990, the newly formed Stark County Board of Health voted to contract with the Henry County Health Department for provision of health department services to Stark County residents.

As of 12/31/11, the Health Department has 40 full time employees and 9 part time employees; in addition, 135 Home Care Assistants are employed on a temporary/as-needed basis.

Board of Health:

The Henry County Health Department is directed by an 8 member Board of Health. Board members are appointed by the chairman of the Henry County Board to three year staggered terms and serve without compensation. By law, the Board must be composed of two physicians, one dentist, one county board member and four citizens-at-large.
